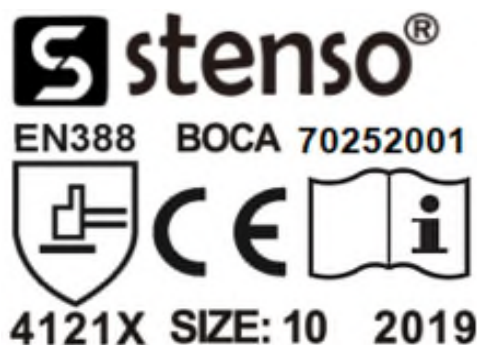

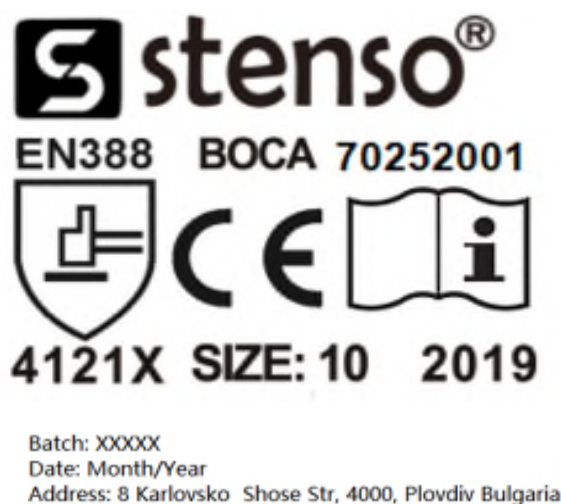

MEANS OF CONTROL

ISO 9001 and internal procedures of below:

Produce procedures

Liners weave together by knit machine. We'll pick out the defective liners one by one when we binding the liner.

We put on the different liner (size) with different hand model (size) and will keep the liner with right position.

Dip coating on the surface of the glove.

Dry the dipped gloves under a certain temperature with certain time.

Take off the glove from the hand model. Pick out the defective glove at the same time.

During the produce procedures, professional staff are making random inspection, possibly 1% of total batch.

Quality procedure

Workers will check the liners one by one and pick out the defective liner with hole or with wrong size after knitting.

Make right position on the hand model before dipping to keep right size.

Keep right position of hand model when dipping deeping depth of the gloves.

Keep stable temperature and proper time when drying.

Pick out the defective gloves when take the glove off the hand model.

Pick out the defective (dipping or size) gloves when packing.

We have professional checking dept to check the gloves after packing, possibly 1% of total batch.

At last, we will pick some samples randomly and sent them to the factory lab or testing institutes to test the quality, for example, EN 388, EN ISO 21420 testing per year.

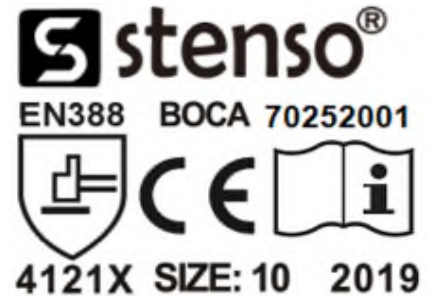
