Functions and
performance levels:

Basic requirements for occupational footwear (OB) (see table 2 and 3 of EN ISO 20347:2012): all mandatory ones, among which the following ones:

SRC (*) = Slip resistance – meets the following requirement:

- surface: ceramic / lubricant: detergent solution;
- surface: steel / lubricant: glycerol.

(*) the final level of the anti-slip features is achieved after the first hours of trial stage.

Additional requirements (see table 16 and 17 of EN ISO 20347:2012):

O1 = closed seat region, antistatic properties, energy absorption of seat region; **FO** = resistance to fuel oil of the outsole.

Marking:

on a stitched label and displaying the following information:

- **CE Marking**;
- Name/Trademark of the Manufacturer + complete address;
- designation of the footwear (alphanumeric code);
- nr. and year of the Standard of reference + protection symbols;
- size of footwear (printed onto the outsole);
- date of production.
