Functions and performance levels:

Basic requirements for occupational footwear (OB) (see Table 2 and 3 of EN ISO 20347:2022+A1:2024): all mandatory ones, among which:

Slip resistance = slip resistance on ceramic tile floor with NaLS.

Additional requirements (Tab. 14 and 17 of EN ISO 20347:2022+A1:2024):

O2 = closed heel area, energy absorption of seat region, antistatic properties, water penetration and absorption; **FO** = resistance to fuel oil.

Marking:

on a stitched label and displaying the following information:

- **CE Marking;**
- Name/Trademark of the Manufacturer + complete address;
- designation of the footwear (alphanumeric code);
- nr. and year of the Standard of reference + protection symbols;
- size of footwear (printed onto the outsole);
- date of production.
